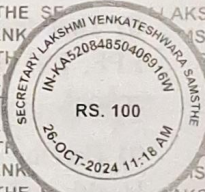



14) That the school shall strive to make efforts for conservation of environment.

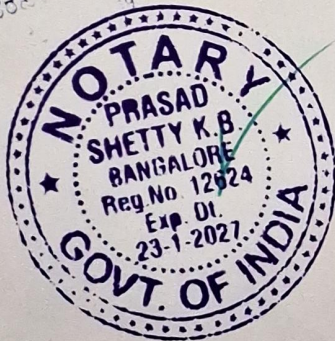
